NOTICE TO BIDDERS:

The following revisions and / or clarifications shall be made to the bidding requirements and contract documents. Revise and amend the documents for the above-named project in accordance with this addendum. The bid shall reflect these addendum changes and each bidder shall make reference in their bid to this addendum.

All bidding requirements and contract documents shall apply to this addendum as originally indicated in the applicable portions of the contract documents, unless otherwise modified by this addendum.

GENERAL

A. THE FOLLOWING ITEMS ARE ISSUED AS RESPONSES TO PRE-BID REQUESTS FOR CLARIFICATION SUBMITTED BY THE BIDDERS:

- 1. Question: Is the metal fence at the Kindergarten Yard on the east side of the campus to remain?
 - Answer: Yes. Please see the revised site map attached.
- 2. Question: Will the pipe on the fence between the church and the school need to be demo'd?
 - Answer: No. The church has been asked to remove it prior to the start of the project on 12/19/22.
- 3. Question: Will the signs hanging on the fence in the field need to be replaced? Answer: No. The contractor will be responsible for removing the signs and giving them to the District to be rehung by the District after the project is complete.
- 4. Question: Are the small portions of fence and the gates around the portable buildings at the northeast section of the campus to be replaced as well?

 Answer: Yes. Please see the revised site map attached. These sections were already included in the District's original estimated measurements.

- 5. Question: The documents reference a middle railing, however the existing 8' vinyl coated fence which is to remain does not include a middle rail. Does the District want a middle rail on the new fence?
 - Answer: No. The new fence should match the existing which is to remain.
- 6. Question: Specifications for Metal Fence and Gates states "as per drawing". However, no drawings are provided. Can you please provide the corresponding drawings so we can prepare a more accurate price quotation?

 Answer: There are no drawings. The reference to drawings in the specifications was made in error.
- 7. Question: Alternate 1, Item number 2. 214 linear ft was specified as length for the 5' metal fencing. However, no length was given for the 6' metal fencing portion. Kindly give us the length of the 6' metal fencing.

 Answer: The length of the 6' fencing was included in the 214 LF estimated measurement. The length of the 6' portion of fencing is 26 LF
- 8. Question: We received the bid documents, but were unable to locate the engineer's estimate.
 - Answer: We do not have an estimate.
- 9. Question: We would like to request the bid date to be reschedule/extended due to the holiday week.

Answer: The District would like to award this contract at the December 13, 2022 Governing Board Meeting. In order to meet this deadline, the bid opening must remain the same, December 1, 2022 at 10:00 AM.

B. THE FOLLOWING ITEMS ARE ISSUED AS CLARIFICATIONS TO THE BID DOCUMENTS:

- 1. Site Map R1 11-28-2022. The original estimated LF from the District already included these clarifications.
- 2. Attached is the Sign In / Out sheet from the non-mandatory bid walk on November 22, 2022
- 3. Attached is the brochure for the metal fencing the District has chosen for Alternate #1. Please see Part C, Item 2 of this addendum for changes to Alternates #2 and #3.

C. PROJECT SPECIFICATIONS


- Appendix A, Alternate #1 Replace Chain Link with New Metal Fencing, Church/School, Item 2: Install new 5' metal fencing, Master Halco Remington-Plus Fence Ornamental Steel Welded Panel Fencing, 2' capped posts approximately 214 LF between the church parking lot and the school parking lot and 6' metal fencing to match around the gutter per the manufacturers instructions. Fence is to be painted to match existing. See brochure attached.
- 2. Appendix A, Alternates #2 and #3: Instead of remove and replace, the District has decided to request pricing in the alternates to sleeve the posts and add an

additional piece to the top of the existing metal fence to extend it from from 6' to 7' and paint the fence to match the existing.
